CONDITIONS OF CONTRACT

- 1. Upon receipt of written confirmation from the School that a place has been allocated, the parents shall: a) pay the Acceptance Deposit;
 - b) become liable for the first term's fees, such fees shall be paid not later than one month before the start of term.
- 2. Fees for subsequent terms shall be paid by the first day of the term for which they are due. In respect of fees not paid by the seventh day from the day they were due, interest will be charged. Failure to pay thereafter may result in exclusion of the child from School.
- 3. Every effort is made to give due notice of any intended fee increase, but the Governors reserve the right to increase the fees without notice.
- 4. No remission of fees can be allowed by absence through illness, or any other cause, including a child's dismissal for whatever reason. Parents are recommended to avail themselves of the School Fees Protection Scheme, particulars of which will be sent with joining instructions.
- 5. In the event of withdrawal of a child, a full term's notice must be given in writing, or a term's fees paid in lieu of notice. A term's fee shall also become payable upon withdrawal of a child after confirmation of allocation of place, but before the start of their intended first term.
- 6. The Head may require the removal of a child if, in his or her opinion, and having consulted the Governors, it is in the interests of the child, other children or the School that the child should leave.
